According to the consent letter of IPO from BSEC, the company is supposed to utilize the whole IPO proceeds within 24 months of IPO Proceeds receipt which will be ended by October 2023 of which Tk.769,475/- as A/C No-01211100000282 of Southeast Bank Limited, Le Meridian Branch, Tk. 466,074.30 as A/c no. 1501204600436001 of BRAC Bank Limited, Gulshan Branch, Tk. 260,000,000/- as Fixed Deposit, interest on FDR Tk 3,168,650 (net of TDS and bank charges) with Southeast Bank Limited, Le Maridian Branch and Tk. 4,841,889.70/- used as working Capital which will be adjusted soon. The balance of the unutilized IPO proceeds is TK. 266,077,439/- as April 30, 2022 after adjusting Bank interest/charges.
